**TO: All Eligible Participants of the  
Alaska Laborers-Construction Industry Legal Services Fund**

**RE: Benefit Changes Effective March 1, 2025**

Effective with services incurred March 1, 2025, the Board of Trustees of the Alaska Laborers-Construction Industry Legal Services Fund (the "Plan"), have adopted the following Plan benefit changes:

**Hour Reimbursement Rate**

The allowed hourly reimbursement rate for legal counsel is increased from \$200 to \$250 for all providers.

**Copay and cost share for In Network Providers**

Claims for code services of 300 to 340 and 500 incurred through one of the **In-Network Providers** (Servicing Law Firm) will now be subject to a 20% copay with the Fund paying 80%.

Benefits for **Out of Network** (all other providers) will remain at the 30% copay with the Fund paying 70% of the allowable charges, up to the maximum allowed benefits per calendar year.

**As a reminder, prior approval is required for using an Attorney other than a Servicing Law Firm.** The Servicing Law Firms for the Trust are listed below:

500	Investigative Services Expense, Depositions, Recording Costs, etc.	\$2,000

The maximum allowable reimbursement rate is \$250 per hour. Subject to the calendar year benefit maximum sub limits for covered legal services, the Plan has an annual benefit maximum for all covered legal services of \$10,000 for each covered participant or eligible dependent in a calendar year. Covered legal services in excess of \$10,000 in a calendar year are not eligible for coverage under this Plan may not be submitted for coverage in succeeding calendar years.

## **Dependents Eligibility**

Effective April 1, 2025, the Plan is extending coverage for unmarried dependent children who have attained age 18 and are incapable of earning his or her own living because of mental or physical incapacity and are chiefly dependent on you for support. Coverage for such child can be continued for the duration of the incapacity provided coverage does not terminate for any other reason. Proof of incapacity must be furnished to the Administration Office within 31 days after the child attains age 18 and must be furnished thereafter as required.
